**Hood Septic-to-Sewer Conversion Project Update | August 11 Town Council Meeting**

July 28, 2022

Dear Hood property owner:

The Sacramento Area Sewer District (SASD) thanks you for your patience as we work through the complex State grant application process for the Hood septic-to-sewer conversion project. We are writing to invite you to an upcoming community meeting and get your input on project participation.

On Thursday, August 11, 2022, the Hood Town Council will host Supervisor Don Nottoli and SASD for a project update (see box at right). We will discuss project progress and funding status, as well as answer any questions you may have.

In the meantime, we ask that all Hood property owners please complete the enclosed interest card to let us know whether or not you are interested in connecting to sewer. Please return the card in the postage-paid envelope by August 11, 2022, or bring it to the Town Council meeting.

To fund and build this project, we will need a high percentage of the property owners to complete and return the interest card. Returning the card does NOT obligate you to connect to sewer. Formal sewer agreements will come later when the project is approved and funded for construction. Homeowners will pay monthly sewer rates once connected, which are currently \$56.85.

This is a great opportunity to switch to sewer at little or no connection cost to you. See reverse for a preliminary map showing where new sewer lines are proposed to be installed. Funding assistance like this is hard to come by, and if you choose to connect later, construction and connection costs for homeowners are typically more than \$10,000.
